| 2 | Improved deactivated dropdown menus | Deactivated programs are removed from dropdown menus, so they can no longer be selected by users when actioning/processing changes to student applications. e.g., once a program has been deactivated, a student will not be able to view that deactivated program when completing their application, nor when editing an application which was already associated with the deactivated program. In such scenarios, users are forced to use only active programs when processing applications. | Enhancement |
| | Improved StudentAid BC Program Code fields | Improved useability guidance for Institution Users as they input the SABC program code fields, so that they recognize the field if a precondition for being able to use the Bulk Upload feature.
